COURSE DESCRIPTION

This course is designed to introduce you to the psychosocial aspects of medical practice and a general overview of clinical psychiatry. Psychiatry includes theories of sociology, psychology & human behavior, as well as integrates the biological sciences of physiology, neuroscience & biochemistry, as they relate to behavior, emotions, personality & motivation over the human life cycle. We will discuss various developmental theories and distinguish between 'normal' mental health and the development of pathological processes and abnormal coping mechanisms. By the end of this course students should have a better understanding for methods of assessment and intervention related to psychotherapeutic results as well as an understanding for the complexity and continuing growth and changes in the field.

DELIVERY METHODS

The course will be delivered through a combination of active learning strategies. These will include:

- PowerPoint lectures and active classroom-based discussion
- E-learning resources: e-reading assignments and practice quizzes through Microsoft Teams

COURSE REGULATIONS

Participation

Class participation and attendance are important elements of every student's learning experience at The Hashemite University, and the student is expected to attend all classes. It is a student's responsibility to monitor the frequency of their own absences. Attendance record begins on the first day of class irrespective of the period allotted to drop/add and late registration. It is a student's responsibility to sign-in; failure to do so will result in a non-attendance being recorded.

In exceptional cases, the student, with the instructor's prior permission, could be exempted from attending a class provided that the number of such occasions does not exceed the limit allowed by the University. The instructor will determine the acceptability of an absence for being absent. A student who misses more than 25% of classes and has a valid excuse for being absent will be allowed to withdraw from the course.

Plagiarism

Plagiarism is considered a serious academic offence and can result in your work losing marks or being failed. HU expects its students to adopt and abide by the highest standards of conduct in their interaction with their professors, peers, and the wider University community. As such, a student is expected not to engage in behaviours that compromise his/her own integrity as well as that of the Hashemite University.

Late or Missed Assignments
