### Aims

- To provide students with an in-depth knowledge and understanding of substantive Jordanian Intellectual Property Law and the impact of EU and International Law on Jordanian provision.

## Learning and Teaching Strategy

The unit will be delivered through a mixture of formal lectures, seminars and directed private study. In addition, other methods may be included such as discussion, debate and workshops. The lectures will be used to provide exposition of the law, procedures and other related issues, whilst seminars and directed private study will be used to underpin and develop understanding of the topic in questions. The lecture and seminar will be delivered in three hours teaching per week.

Scheduled Activities				
Week 1	Introduction to Intellectual Property Law. This includes definition, nature, history, objectives, source, divisions, protection and legal frameworks.			
Week 2	Introduction to Industrial property. This includes patents and industrial design, conceptual and legal definition of patents, importance and legal requirement of the patent.			
Week 3	The essentially five substantive requirements and the 14 formal and procedural requirements.			
Week 4	Finishing the 14 procedural requirements and tackling the patent protection			
Week 5	Civil and penal protection for patent, international protection and other court procedures.			
Week 6	<u>First exam</u> + Introduction to commercial property. This includes trademark, trade name and trade address, conceptual and legal definition of trademark, importance, the legal requirement of the trademark.			
Week 7	Legal and illegal elements of trade mark and the different type of trademarks. In addition to a judicial application on the famous trademark.			
Week 8	The essential substantive requirements of trademark, legal requirement, procedures, conflicts, discretion and other legal issues.			
Week 9	civil and penal protection of the trademark			
Week 10	<u>Second exam</u> + trade name definition, importance, legal framework, governance system and discretion.			
Week 11	Introduction to Company Law in order to determine the type of companies that should register a trade name. In addition, determine the form of trade name of each company. Further, different application will be demonstrated.			
Week 12	Trade address definition, importance, legal framework, the governance system and discretion. In addition, the importance of trade address will be demonstrated in relation to e-commerce.			
Week 13	Determine the form of trade address of each company. Further, different application will be demonstrated. Distinguishing trade name from trade address. Further discussion will be made in relation to the linkage with trademarks.			
Week 14	Introduction to industrial design. This includes definition, importance, legal framework, governance system, legal requirements and protection.			
Week 15	Looking at different international convention in relation to intellectual property rights.
