Course Description
<p>This course discusses the scientific aspects of cosmetics. It describes various cosmetics and cosmeceuticals available in community pharmacies such as moisturizers, skin cleansers, masks, sunscreens, as well as acne, skin pigmentation and skin aging ameliorating products. It discusses the effects of various ingredients of cosmetics on skin &amp; hair and their mode of action using data supported by scientifically researched criteria. In addition, local and international legal requirements for cosmetics registration and labelling as well as basic principles of formulations of some cosmetics will be discussed. The course is offered through lectures enriched with case studies and assignments.</p> <p>مساق مستحضرات التجميل: يناقش هذا المقرر الدراسي الجوانب العلمية لمستحضرات التجميل، سيتم دراسة العديد من المستحضرات التجميلية والتجميلية الصيدلانية المتوفرة في الصيدلية مثل المرطبات ومنظفات البشرة والأقنعة وواقبات الشمس، بالإضافة إلى مستحضرات حب الشباب وتصبغ الجلد ومنتجات تحسين شيخوخة الجلد. سيتم مناقشة تأثير المكونات المختلفة لهذه المستحضرات على البشرة والشعر وطريقة عملها باستخدام بيانات مدعومة بمعايير بحثية علمية والقوانين الناظمة محليا وعالميا لتسجيل وتسويق مستحضرات التجميل ومتطلبات بطاقة البيان و مبادئ اساسية لتركيب بعض مستحضرات التجميل . يتم تقديم المساق من خلال محاضرات غنية بدراسات الحالة والواجبات.</p>

Up to date guidelines for management of common skin disorders such as acne and eczema</li><li>8. Evidence based practice for innovative cosmetic ingredients</li><li>9. Understand the ingredients' label of skin care products and correlate it with claims written on the products</li><li>10. Develop knowledge on the national and international regulations governing cosmetics</li></ol>
