Courses Description

This course explains the principles of commercial law and consists of studying the origin, development of commercial law and its sources, definition and scope, the relationship between commercial law and civil law, commercial activities, merchants, mandatory commercial books, commerce registry, trade name, business premises, and finally an explanation for commercial contracts: commercial mortgage, contract of carriage of things and persons, commercial agency and finally brokerage.

Objectives:

The main objective of studying principles of commercial law is to give the undergraduates the necessary background in the leading principles of commercial law as applied to business for their professional developments.

This course aims to enable the students to familiarize themselves with all aspects of commercial law establishing a background for students studying other advanced topics of commercial law. By the end of this course the students will have acquired a deep understanding of the principles of commercial law and be able to apply that knowledge to the solution of the sorts of problems encountered in trade.
