<b>Aims</b>
<ul style="list-style-type: none"> <li>• To provide students with an in-depth knowledge and understanding of substantive Jordanian legal system in relation to the legal obligation, duties, commitments and the application of the related provision and resulted legal effect</li> <li>• To understand effects of obligations (Natural and civil obligation and Obligatory implementation of the obligation)</li> <li>• To understand the sources of obligation how its legal effect can be created</li> <li>• To determine all legal effect and the way to apply them on certain obligations</li> <li>• To understand the different legal way to fulfil the legal obligation</li> </ul>

- To understand the alternative way to fulfil legal obligation
- To understand all types of legal obligations and their different legal effect
- To enable students to appreciate the political, social and economic reasons for the importance of the governance system of the rules that cover commercial and civil obligation and the various influences on legislators when developing legislation.
- To examine the effectiveness of current Jordanian civil and commercial law in relation with the legal effect resulted from obligation, commitment and duty
- To develop students' ability to analyze the law by applying it to problem scenarios and discussion based questions.

- Demonstrate an in-depth knowledge of substantive Jordanian civil Law and the impact of the rules that govern obligation
- To develop students' ability to deal and analyze case law and scenario and apply related rules
- To develop students' ability to deal with different form of obligations
- Develop legal skills to deal with the provisions of commitments
- Critically evaluate the effectiveness of the different forms of obligations and duties and making a clear distinction between each legal effect resulted from legal obligation
- Develop logical and coherent arguments to support reasoned conclusions when answering problem or discussion based questions
- Critically analyze the role of the Jordanian legislator in tackling and governing the contract of sale
- Demonstrate an in-depth knowledge of substantive Jordanian civil Law and the impact of the rules that govern obligation

### ***Learning and Teaching Strategy***
